**OPENING PRAYER & HONOURING LAND & TERRITORY**

The meeting opened with a prayer led by Superintendent Crowell and honoured the land and Territory of the Mississauga's of the Credit First Nation.

## WELCOME, HOUSEKEEPING ITEMS, AND MEETING GOALS

F. Thibeault, Senior Manager, Planning Services welcomed all parent volunteers to the committee and proceeded into addressing the housekeeping items for the meeting.

The SBRC approved the SBRC Working Meeting #6 meeting minutes, which will be posted on the public website ([click here](#)). No changes were requested by the SBRC.

F. Thibeault reviewed the Goals of the meeting, which were:

- 1) Review Top 3 Interim Accommodation Options.
- 2) Discuss how the next phase of community outreach will be undertaken.
- 3) Are ready for the next VPIM.
- 4) Next Steps.

## PREFERRED INTERIM ACCOMMODATION PLAN:

### Interim to Ultimate

F. Thibeault explained the three (3) Interim to Ultimate options including the pros and cons of each option. The options are as follows:

- Option A: Lester B. Pearson Holding School Option
- Option B: E.C. Drury Holding School Option
- Option C: Increased Capacity at Jean Vanier CSS

The committee liked the pros and cons charts and suggested that both formats be included in the survey so the community can read the detailed information before completing the survey.

## SURVEY vs. VPIM #2:

### Should we survey or should we go?

F. Thibeault explained the two (2) next steps options, which are as follows:

F. Thibeault suggested if the committee moves forward with three (3) options, then we should proceed with the survey to provide more detailed information in order to whittle down the options to a preferred and alternative. R. Merrick offered a polling activity for committee members to vote on the following:

**Q1: How many interim year (2021-22) options do you suggest moving ahead with?**

- About half of the committee members voted to move ahead with two (2) options.
- About half of the committee members voted to move ahead with three (3) options.

**Q2: What is your preferred interim holding option?**

- The vast majority of the committee members voted for Lester B. Pearson HS as their preferred option.

Based on the polling results, the committee decided to move ahead with the **Survey Process: Next Steps to Board of Trustees**. The following comments and suggestions were made supporting this decision:

- Based on community concerns over the overcrowding of students and the number of portables being added to Jean Vanier CSS, Milton Trustees' perspective is that this issue should be addressed in detail, so the community has detailed information on this option.
- Due to the polling results being so close, the committee should not rush the process.
- In the survey, show the order of the preferred options. Indicate that each option has its pros and cons, and we are trying to find the best option.
- Provide detailed information without becoming too cumbersome.
- Ask the community to complete the survey and have their voices heard.
- Address common themes from the first survey (ie. Non-Catholic students attending Jean Vanier CSS, the change from staying in Milton being the most popular vote to now transporting students to Burlington).

The Planning Department will work on the survey and have that out as soon as possible. F. Thibeault stated that this process will most likely go beyond the June timeline in order to provide adequate time for the community to respond to the survey and the Board to review the results.
